Undersecretary **GIL S. BELTRAN** has been an Undersecretary of DOF since 2005 and was appointed as the Chief Economist of the Department of Finance in 2013. Usec. Beltran has been working on a variety of areas including fiscal policy, human resource and operations management, economic policy and research, and financial inclusion policies and strategies. He has been Executive Director of the National Credit Council since 1998.

Mr. Beltran graduated with a Master of Arts degree in Development Economics in 1982 as class valedictorian from Williams College, Williamstown, Massachusetts and a bachelor's degree in economics cum laude in 1978 from the University of the Philippines.

He is also a Visiting Lecturer, University of the Philippines College of Public Administration from 2006 to the present and the Development Academy of the Philippines since 2010.

He has held various posts at the World Bank as Alternate Executive Director from January 2003 to January 2005; and Advisor to Executive Director, from February to May 1995 and August to November 1990.

Rosemarie Edillon is presently the UnderSecretary for Policy and Planning at the National Economic and Development Authority. She holds a PhD in Economics from La Trobe University in Australia, an MA degree in Economics from the UP School of Economics and an MS degree in Statistics from the UP School of Statistics. She also taught Economics at La Trobe University and Economics and Statistics at UP. Before this, she was Executive Director of the Asia-Pacific Policy Center, a research firm that focuses on development policy research.

Her first exposure to Economics was the development of the Philippines annual macroeconometric model and then the ASEAN macro-model. She has since then worked in various fields of specialisation in Economics – agriculture, agrarian reform, poverty, labor, migration, project development, impact evaluation, health, social capital, growth theory and global business.

She is also currently the President of the Philippine Economic Society and the Vice-Chair of the Economic Committee of the APEC.

Diwa C. Guinigundo is Deputy Governor for the Monetary Stability Sector, Bangko Sentral ng Pilipinas, which he has been serving for over 37 years. He became assistant governor for monetary policy and international operations prior to his appointment as deputy governor in 2005.

In 2001-2003, he was Alternate Executive Director in the Philippines' constituency at the International Monetary Fund in Washington, DC. Earlier he was Head of Research at The SEACEN (Southeast Asian Central Banks) Centre in Kuala Lumpur in 1992-1994.

Since 2000, Deputy Governor Guinigundo has co-chaired with Bank Negara Malaysia the SEACEN Experts Group on Capital Flows and in 2010-2013, the ASEAN Senior Level Committee on Financial Integration. He also chairs the SEACEN Task Force on SEACEN membership.

For the period 2009-2012, he chaired the Executive Meeting of East Asia and the Pacific (EMEAP) Monetary and Financial Stability Committee of EMEAP central bank deputies that is tasked to conduct regional and global surveillance.

Deputy Governor Guinigundo graduated, cum laude, at the top of his AB Economics Class at the University of the Philippines (UP) School of Economics. He earned the M.Sc. degree in Economics at the London School of Economics (LSE) as a scholar of the Central Bank of the Philippines.
